# **Horizon Homes, Inc. Privacy and Data Protection Policy**

Protecting your private information is our priority. #### **Collection of Your Personal Information**

We do not collect any personal information about you unless you voluntarily provide it to us. - or prosecute those responsible for that activity;
   Debug to identify and repair errors that impair existing intended functionality; Exercise free
- speech, ensure the right of another consumer to exercise his or her right of free speech, or
- exercise another right provided for by law;
   Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public
- interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent; Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or

  Otherwise use your personal information, internally, in a lawful.
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
